EFFECTS OF OVEREXPOSURE

PRIMARY ROUTE OF ENTRY

EYES: SEVERE EYE IRRITANT. POWDER DUSTS MAY DAMAGE THE EYES CAUSING CORNEAL INJURY.

SKIN: MOISTURE ON SKIN SUCH AS PERSPIRATION OR WATER WILL CREATE HEAT WHICH MAY BURN SKIN.

INHALATION: MAY BE IRRITATING TO THE MUCOUS MEMBRANES TO THE NOSE, THROAT, LUNGS. CHOKING, COUGHING OR HEADACHE MAY OCCUR.

INGESTION: IRRITATION TO THE MOUTH, THROAT AND GASTROINTESTINAL SYSTEM. LARGE AMOUNTS MAY CAUSE VOMITING AND DIARRHEA.

FIRST AID PROCEDURES

SKIN: REMOVE CONTAMINATED CLOTHING. FLUSH AFFECTED AREA WITH WATER. SEEK MEDICAL ATTENTION IF IRRITATION PERSISTS.

EYES: FLUSH EYES WITH LARGE QUANTITIES OF WATER. SEEK MEDICAL ATTENTION IF IRRITATION PERSISTS.

INHALATION: GET FRESH AIR. SEEK MEDICAL ATTENTION IF IRRITATION PERSISTS.

INGESTION: DO NOT INDUCE VOMITING. CONSULT A PHYSICIAN. IF PERSON IS CONSCIOUS, DRINK LARGE QUANTITIES OF WATER.
